8a. Motion to alter the Disabled Students' Campaign Constitution

Proposed by Robert Corbyn-Smith and Calista Winstanley

CUSU Notes

1. That following the successful re-launch of the Disabled Students' Campaign (henceforth abbreviated to DSC), the committee believed that a thorough review of its constitution was desirable to ensure that it meets the current and future needs of the campaign and its members. Following the procedure laid out in the current DSC constitution, the committee asked for the input of other members and successfully passed the proposed constitutional amendments in a quorate open meeting.
2. That the current constitution excludes intermitting disabled students from being campaign members.
3. That the current quorum requirements are both a) high compared to other autonomous campaigns and b) do not change to reflect the level of active participation in the campaign.
4. That the current constitution refers to, but does not have, standing orders.

CUSU Believes

1. That intermitting disabled students deserve the support of their university and their student's union throughout their intermission, and as such, should be allowed to be campaign members.

2. That quoracy is a valid way of ensuring that a decision of a campaign is representative of its members and their interests, and should be adjusted to reflect the number of active members.
3. That the constitution could be better served by the removal of certain specifics into a set of accompanying standing orders that govern how the principles of the constitution should be enacted.
4. That any other constitutional amendments not previously specified that are included within this motion (see attached documents for full changes) by the DSC are sufficiently justified and in accordance with the aims and practices of both the DSC and CUSU.

CUSU Resolves

1. To ratify the constitutional amendments needed for intermitting students to be allowed to be campaign members by changing “B.1 The Disabled Students' Campaign shall be an association of the members of the University of Cambridge in statu pupillari who self-define as disabled, or who have themselves experienced disability, and are pursuing a course of study or research in the University.” to “The Disabled Students' Campaign shall be an association of the members of the University of Cambridge in statu pupillari who self-define as disabled, or who have themselves experienced disability, and are pursuing or intermitting from a course of study or research in the University.”
2. To ratify the constitutional amendments for the quorum requirement from “C. 3 Quoracy for Open Meetings shall be 10 or more members of the Campaign participating in the decision-making process. Decisions of a non-quorate Open Meeting may be ratified at the next quorate Open Meeting.” to “C. 3 Quoracy for Open Meetings shall be 1/15 of the total number of votes cast in the most recent election of the Disabled Students Officer, or 1.5 times the current number of members on the executive committee, whichever is the greater, with a minimum of five and a maximum of twenty five. Decisions of a non-quorate Open Meeting may be ratified at the next quorate Open Meeting. It shall be the duty of the campaign to make voting on campaign decisions to be as accessible as possible; to this aim, quoracy requirements where possible can be satisfied by the votes of members that are not physically present at an open meeting.”
3. To ratify the creation of standing orders which are to be written by the DSC in consultation with its members, at the next available opportunity, and the removal of specifics from the constitution.
4. To ratify any other constitutional amendments proposed within this motion.

8b. We Support Women in Sport Project

CUSU Notes

1. Sport is an integral part of the University of Cambridge community
2. The ability to participate in sport has been shown to benefit students in a wide range of areas, including physical health, mental health, community building, and retention rates in degree programs.

3. There are currently significant differences in funding, resources and attitudes toward women, transgender and genderqueer in sport, that act as barriers to their participation and success.

CUSU Believes

1. In the eradication of gender-based disadvantages at Cambridge.
2. All students should be given equal access to participate in College and University level sport.
3. It is important that equal access to sport is supported by the attitudes of members of the university community.

CUSU Resolves

1. To support the We Sport Women in Sport campaign, by the amount of 100 GBP, in order for the campaign to purchase stickers that promote the campaign, to be included in pamphlets given out at varsity matches. This will allow the project to reach a wide variety of individuals already in the sporting community.

CUSU Resolves

1. To adopt the new Sabbatical Officer contracts and make them available to prospective candidates for sabbatical roles.
